# 4. First-aid Measures

# 5. Fire-fighting Measures

# 6. Accidental Release Measures

# 7. Handling and Storage

Do not store above 120 ° F. Store large quantities in buildings designed and protected for storage of NFPA Class II combustible liquids. Keep away from heat, sparks, flame and sources of ignition. ## PERSONAL PROTECTION

# 10. Stability and Reactivity
